- 6) A) A Workshop or Convention of all the Officers of WBJSW Service might be convened early to take final stand on our future movement on Service issues. General Secretary was authorised to discuss with Other Associations or Association members to participate such workshop or Convention.
 - B) An academic Workshop or Seminar on a suitable topic to suit different facets of administrator of Social Welfare Administration might be organised. Efforts might be taken to ensure participation of academic experts on the issue and our HMOS might be invited to inaugurate such workshop. Details of such proposal would be placed in the next EC meeting.
 - C) Decentralised District level Orientation of Freshers' of 2014 Batch might be organised and all the District Secretaries were requested to invite all such Officers of 2014 batch of concerned District for District level orientation.



D) District whatsapp group under the Association's banner might be created by District Secretary's own initiative and update all members through such group about current development of every issue whether it is regarding association or Department.
