NOTIFICATION

Consequent upon bifurcation of WCD and SW Department into Child Development Department and WD & SW Department as well as increasing job assignments, Governor is hereby pleased to create two new Directorates, namely Directorate of ICDS and Directorate of Child Rights and Trafficking along with the existing Directorate of Social Welfare. The details job assignment of the three Directorates is stated below:-

- Directorate of ICDS under Department of Child Development (newly created)
 Assigned job:
 - i) Flagship and gigantic Project Integrated Child Development Services Scheme.
 - ii) Indira Gandhi Matritva Sahayak Yojana (IGMSY), Rajiv Gandhi Scheme for Empowerment of Adolescent Girls (SABLA), Kishori Shakti Yojana (KSY)
 - iii) Implementation of The Infant Milk Substitutes, Feeding Bottles and Infant Foods (Regulation of Production, Supply and Distribution) Act 1992 with amendment in 2003.
- 2. Directorate of Child Rights and Trafficking under Department of Child Development (newly created):-

- xvi) Rest any job presently undertaken by the Directorate of social Welfare but not included in the job assignment of any of the Directorates will be undertaken by the Directorate of Social Welfare.

In the process of creation of two new Directorates and restructuring of existing Directorate of Social Welfare

- i) total 158 (one hundred and fifty eight) new posts are created details of which is given in annex
 -1,
- ii) total 55 (fifty five) no of posts with 2 (two) no of posts converted with new designation which are presently included in ICDS wing of existing Directorate of Social Welfare is being transferred to the newly created Directorate of ICDS details of which is given in annex 2,
- iii) total 10 (ten) no of posts included in different wings of existing Directorate of Social Welfare is being converted with new designation with new set of recruitment process and distributed between Directorate of ICDS and Directorate of Social Welfare as detailed in annex 3,
- iv) Thus total distribution of all the existing posts of Directorate of Social Welfare included in different wings along with new creation of 158 posts for the newly created directorates are given in annex 4,
- v) In the process of bifurcation if at later stage any existing post is found not included in any of the three Directorates will be included in Directorate of Social Welfare with the concurrence from Finance Department.

- vi) After initiation of function of three new Directorates the process of creation of new DDO code for each Directorate and separate Head of Accounts will be initiated, till then existing DDO code of Directorate of Social Welfare will be used by the all the three Directorates. The other two Directors will suitably arrange to provide ministerial assistance to the existing DDO in due discharge of duties in view of enhanced job due to creation of the Directorates.
- vii) All the three Directorates will be housed in three different spaces in due course of time, till then all the Directorates will function from Juvenile Court Building.
- viii) Three new Directorates will start functioning as soon as new Officers are posted as Directors for the three Directorates. Before functioning separately the following posts available to the new Directorates will be filled up by eligible staffs by promotion from the existing Directorate. After the exercise of promotion is over all the staff of existing Directorate will be asked to exercise option for inclusion in any of the three Directorates. In case of HA, if number of Staff opting for a particular Directorate exceeds the number of posts of HA available with that Directorate, Department will decide on the basis of seniority.
 - a) Post of HA to be filled up by promotion from all the confirmed UDA / Accountant of the existing Directorate.
 - b) Post of OSD (Registrar) will filled up by promotion from all the Head Assistants of the Directorate of Social Welfare.
 - c) Post of UDA to be filled up by promotion from all the confirmed LDA of the existing Directorate.
 - d) Before splitting of Directorate existing LDA, UDA, HA of the existing Directorate of Social Welfare will be given opportunity for promotion available to that category considering all such posts of all the three Directorates together for one time only. After initial roll out concerned Directors will be appointing authorities for those posts and recruit accordingly.
- ix) In case of Posts of Assistant Director, Deputy Director and Joint Director which will be filled up by the Officers promoted from the WBJSW Service, the Officers will be appointed by the Department as Governor of West Bengal is their appointing authority and they may be posted or transferred to any of the three Directorates. For filling up of different posts to be manned by IAS / WBCS (Exe) Officers P & AR department will be moved.
